JRF SCHOLARS ARE FROM DIVERSE BACKGROUNDS; HOWEVER, THEY ARE UNITED IN THEIR DETERMINATION AND DRIVE TO CONQUER POVERTY. TO BE ELIGIBLE, APPLICANTS MUST BE WOMEN AGES 35 AND OLDER, U.S. CITIZENS, LOW INCOME BY U.S. DEPT. OF LABOR LOW INCOME STANDARDS, AND ENROLLED IN AN ACCREDITED SCHOOL.

AWARD RECIPIENTS ARE SELECTED ANNUALLY FROM HUNDREDS OF APPLICATIONS IN A COMPETITIVE, THREE-TIER REVIEW PROCESS. SCHOLAR SELECTION IS ORGANIZED BY STAFF AND CARRIED OUT BY ABOUT 200 COMMUNITY VOLUNTEERS.
