WE HAVE GIVEN 1,604 SCHOLARSHIPS TO 1,016 WOMEN IN THE AMOUNT OF \$3,020,000. ADDITIONALLY, WE MERGED WITH THE EMERGE SCHOLARSHIP FUND, A SCHOLARSHIP FUND FOR LOW INCOME WOMEN IN GEORGIA OVER THE AGE OF 25 IN OCTOBER 2018. JEANNETTE RANKIN SCHOLARS ARE ABLE TO LEVERAGE THE SCHOLARSHIP, USING IT TO FILL IN THE GAPS FOR EXPENSES NOT COVERED BY OTHER SCHOLARSHIPS INCLUDING: BOOKS, CHILDCARE, HOUSING EXPENSE, AND CAR REPAIRS. THERE ARE MULTIPLE STORIES ABOUT HOW A SMALL CASH SHORTFALL CREATED A DOWNWARD SPIRAL. A FLAT TIRE OR UNEXPECTED MEDICAL EXPENSE HAS THE POTENTIAL TO END A COLLEGE EDUCATION FOR OUR SCHOLARS. OUR GOAL IS TO MAKE SURE THAT THIS DOES NOT HAPPEN
